Complaint and Inquiry Summary

Section 1002.421(2)(a)3., F.S., requires the Department to establish a process by which individuals may notify the Department of any violation of state laws relating to program participation by a parent, private school or school district. To comply with this section, a complaint specialist position was established. Duties of the position include being responsible for receiving the initial complaints via email or telephone through the toll-free information hotline and assisting the complainant in completing and submitting the formal complaint form.

When a signed formal complaint form is received, it is reviewed by the Department for legal sufficiency. A complaint is legally sufficient if it contains ultimate facts that show that a violation of applicable law or rule may have occurred. Formal complaints found legally sufficient either have an inquiry opened or the complaint is referred to the appropriate organization for investigation.

The Department's complaint and inquiry process is codified in State Board Rule 6A-6.03315, F.A.C., and tracked through an administrative function on the IEPC website. Below is the complaint and inquiry summary for the 2022-2023 school year.

A total of 197 written formal complaints were submitted to the Department from 2022-2023. Ninety-six of the total written formal complaints were found to be not legally sufficient. A statement that a student is a homosexual, bisexual, or otherwise immoral, or words to that effect or language or behavior that a reasonable person would believe is intended to convey the statement that a student engages in or has a propensity or intent to engage in immoral and/or homosexual

Definition of "identifying statement"

Examples: "I am gay," "I am a homosexual," "I have a homosexual orientation."

Homosexual conduct, defined as acts or identifying statements, is incompatible with enrollment at Evangelical Christian School and is a basis for dismissal. All students must be treated with dignity and respect, free of threats or harassment.

Statement on Marriage and Sexuality

We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God. (Gen 1:26-27) Rejection of one's biological gender is a rejection of the image of God within that person.



Anti-LGBTQ schools receive state vouchers

More than \$129M in Florida scholarships went to students who attended private schools where gays are condemned or unwelcome

n the shadow of a nearly 200-foot cross, Central Florida Christian Academy enrolls students who live by the Bible's commands and abstain from "sexual immorality" - meaning gay children aren't welcome on the statesupported campus in west Or-

Calvary Christian High School in Clearwater denies admission to students if they, or someone in their home, are practicing a "homosexual lifestyle or alternative gender identity" or "promoting

Wade Christian School in Melbourne keeps an "expulsion list," with a "homosexual act" among the offenses, alongside bringing weapons to campus, distributing drugs and striking a staff member. In Florida last year, 156 private Christian schools with these types of anti-gay views educated
